

Payments to successful bidder will be made as follows; 30% of bid value after successful CAMC at end of 1<sup>st</sup> year, next 30% of bid value after successful CAMC at end of 2<sup>nd</sup> year and last 40 % of bid value after successful CAMC at end of 3<sup>rd</sup> year. Successful bidder shall have to dismantle & Safely store all the network infrastructure along with all linked e-services between Shri Kedarnath Dham to Sonprayag at the end of each yatra season and re-install it before the start of next yatra season.
